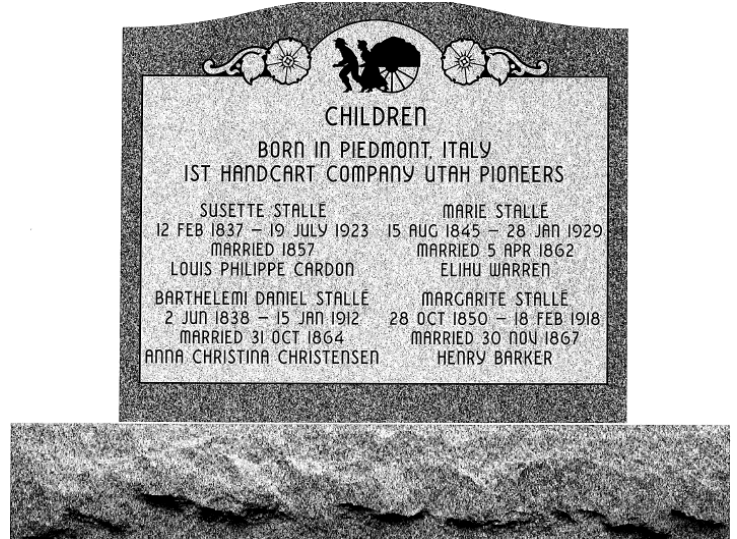
THE GRAVEMARKER OF JEANNE MARIE GAUDIN-MOISE STALLE IN HYRUM,UT

Paolo's daughter Marie Danna b abt 1596 md Pietro Stallé abt 1616. Pietro is my 8th great grandfather. It is apparent how many closely related Waldensians intermarried. Daniel and his wife had five children: **Jean, Antonio, Marie, Francesca,** and Catterina. They are my first cousins 11 times removed. The temple ordinance work for Catterina has been done. The temple ordinance work for her 4 siblings above in **bold** has been submitted.

RESEARCH STATUS IN THE PIEDMONT REGION

Lately I re-checked all the material that has been transcribed in the past years. I spent a month in Italy in December checking in the State Archives if all existing documents have been transcribed. I don't think there is anything left to transcribe except for completing the series of volumes from FROSSASCO. Previously I transcribed the FROSSASCO volumes from 1610-1630 contained in Insinuazione di PINEROLO. In the Insinuazione di SAN SECONDO there is the series of FROSSASCO volumes from 1630 to 1727. Of these I currently transcribed volume 108 (3 books) which covers years 1702-1705. I am sending you the first two of the books (covering 1702 to 1703) so you can evaluate them and decide whether they contain the genealogy of your ancestors. In February I plan another trip to Italy, and I can scan the remaining FROSSASCO volumes (1630-1712) and transcribe them if you think they are of interest. If you could let me know before February 15 it would be appreciated.

FUTURE OF THE PFO AND PFO REPORTS

In 1978, at the urging of Hugh T. Law (the Genealogical Department's European specialist), an organization of Waldensian families was created. The first project was to extract genealogical information from Mentoulles, missed in the Piedmont Project because those parish registers were no longer among the Waldensian records. In 1980, under the direction of Marriner Cardon, a lawyer of Waldensian descent, the PFO registered with the IRS as an official, tax-exempt organization [under Section 501(c)(3)]. Ron Malan's interest in family history began in the mid-1950. His Piedmont interest began in 1989 when he learned from Hugh Law that there were many volumes of records in Torino, Italy which had not been microfilmed. The Family History Library had so many other projects going on and it appeared that those records would likely never be microfilmed. Ron learned of an Italian researcher, Giovanni Cena, who might be willing to extract information from those records. In April 1992 the first notary reports arrived from Brother Cena. Not long after he began extracting from those records. Brother Cena told Ron that he was having so many spiritual experiences working in those records that he was retiring early so he could devote more time to this important work--and retiring at a significant loss in retirement benefits. When Sister Cena died unexpectedly a few years ago, there were still two small sons to care for. Brother Cena moved to the Canary Islands so he would have the help of grandparents to care for those boys. Yet he continued to make trips back to Torino, Italy to extract those Waldensian records for us. Ron continued the tax-exempt status of the PFO, an umbrella organization for all families from the Piedmont Valleys. He wrote the PFO Reports in order to get financial support for the research and to share the results with families who have ancestors from the Piedmont Valleys.

I began my contributions to the PFO Reports in 2000. I have spent many hours searching the notary records to identify connections to our ancestors. I have felt the inspiration and direction of the spirit in doing the research and helping others do the ordinance work for our ancestors. My brother, Labor, joined with me to help with the research. Since Ron Malan died in November 2013, I have continued to publish the PFO Reports and to encourage donations to the PFO fund.

What will be the future of PFO and PFO Reports? I will continue to prepare periodic PFO Reports, to support and to invite people to assist financing the PFO organization. As we get closer to Giovanni Cena finishing his notary research, I suggest that we continue to employ Bro. Cena to send us photos of original birth, marriage, and death documents of the Piedmont Families ancestors from the earliest available until 1860 with the translation. These can be then be posted on Family Tree to document our records. Also, I will continue study Ron Malan's research material that his his wife gave me. Both

Lavor and I will continue to do research and find additional ancestors who need temple ordinances. However, we need younger descendants to volunteer to help. While searching the in 1615 notary records, I discovered that in about 1605 Davide Cardon (4th great grand uncle of Philippe Cardon), son of deceased Matteo married **Maria PASCHETO MAGNARD**, daughter of **Michele PASCHETO MAGNARD** and his first wife **Beatrice**. Michele was the son of deceased **Pietro PASCHETO** of San Secondo. Matteo Cardon was from Roccapiatta. The names of the people in bold are new need the necessary temple ordinances.
