The great majority of donations for our research project in the notarial records has come from just two families: the Cardons and the Malans.

Results of the research affecting the Malan pedigree are featured in *The Malan Monitor* newsletter. For that reason, little research has been included in the PFO newsletter that extends that Malan pedigree.

To express appreciation to the Cardon family for their substantial support of the research project, this issue is dedicated to entries that relate to the Cardon pedigree. The Cardons have two Malan lines, but the relationship to the ancestors of John Daniel Malan (the Malan family's immigrant ancestor) isn't yet clear. This issue also summarizes records pertaining to the Cardon Malan lines, to date.

Cardon surnames in the Luserna San Giovanni notarial records

[Notarial entries from volume 47 (1685) through volume 39 (1672). Genealogical research always proceeds from the known (most recent) to the unknown (more remote), so the volumes are being extracted in order from the latest to the earliest. Note that surname spellings were not standardized at the time of these records, and that all names appear in their Italian form. Where the French form differs substantially from the Italian, the French is also given. Information in parentheses at the end of each entry provides the page number in the volume and the date the record was made. NOTE: The year attached to the volume number is when the notary deposited the record with the Duke's officers—not necessarily even the year in which the original record was made. E.g., the fifth entry below, made in 1642, was not recorded until 1685.]

Retrosale: Brothers deceased Bartholomeo, Antonio, Giovanni, and Daniele TURINO sons of deceased Michele; Daniele GENOLATO son of deceased Paolo; Catterina daughter of Hercule DANNA (son of deceased Steffano) and wife of Giovanni TURINO (son of deceased Matteo); deceased Margarita daughter of deceased Giovanni FELICIANO, wife first of deceased Bartholomeo TURNIO (son of deceased Matteo) and then of Giovanni GIOVINE (son of deceased Paolo); and Maria daughter of said deceased Margarita and Giovanni GIOVINE. Restitution of dowry: Deceased Daniele CAFFARELLO (died 1682); widow Anna daughter of deceased Daniele RICHIARDO-DAVI; her future second husband Paolo FAVOTTO son of deceased Daniele. (1683, 65, 15 Mar 1683)

Marriage settlement: Daniele VIGNA son of deceased Daniele; wife Cattarina daughter of deceased Giovanni GIOVINE; her brothers Giuseppe and Giovanni. (1683, 67, 16 Mar 1683)

Retrosale: Paulo BASTIA son of deceased Paulo (son himself of deceased Michele) and of Margarita; his uncle Bartholomeo GONINO; siblings of said Paulo BASTIA:

(other relatives). (1682, 121 & 129, 9 Jun & 20 Mar 1682)

Purchase: Sisters Gioanna and Sussana, daughters of deceased Daniele GIRARDO, from Daniele GIOVINE son of deceased Giuseppe. (1682, 144, 12 May 1682)

Will: Giovanni MALLANO son of deceased Sidracco; wife Ester daughter of deceased Michelle BELLIONE; their daughters Margarita and Zabellina, and sons Sidracco, Michelle, and Bartolomeo; Ester's brother Davide MALLANO. (1681, 107, 10 Jul 1680; these same people also mentioned in deposition, p. 153, 5 Sep 1682)
