We continue here our notarial records highlights.

Because so many of the surnames appear on the pedigrees of our separate families, we present them in alphabetical order. This avoids having to repeat them. We also present the extractions by separate volume to simplify the reports.

Numbers in parentheses indicate the page number in the volume and the date of the act. NOTE: The year attached to the volume number is when the notary officially *deposited* the record—not necessarily the year in which the original record was made. Sometimes it is the same year, but often the notary (because he had to pay a fee each time) delayed registering some acts.

[An ongoing column featuring the suffering of our ancestors, as represented by the inheritance claims of the Exile survivors.]

13 Nov 1697: Bartholomeo GONINO, son of deceased Davide, for himself and his brother Davide and their paternal uncle Giovanni GONINO, claims inheritance of his grandfather Bartholomeo GONINO (son of deceased Davide), who died in 1693, an exile in Switzerland. (Senato 97, p. 235)

13 Nov 1697: Giuseppe GONINO son of deceased Giuseppe (who died 1686 in Fossano prison), for self and his sisters Madalena and Suzanne, claim inheritance of their father and also of their brother Giovanni, who died in 1691. (Senato 97, p. 59)

Let us ever be grateful for our faithful heritage.
