## RESEARCHER STATUS

On 22 August 2004, Giovanni Cena's wife died of a blood clot to the brain. With two sons still in elementary school and his aging parents' health failing, he has had to consulate his "care-giving" by moving to be with his parents. They now live in the Canary Islands (for their health), and so he is now far from the State Archives in Torino.

Since then, we have explored several options for continuing our research—we have only about 60 volumes predating the parish registers yet to go. Finding another researcher would cost us at least **five** times as much as Brother Cena charges us, and would put him in a bind, for he retired early as a school teacher in order to research fulltime for us. He cannot teach in the Canary Islands, not knowing Spanish.

A key Family History Department leader told us before we began working with Brother Cena that the Church would never microfilm these notary records because they already had permission to film so many vital records. Nevertheless, at the same time he told us that, the Church was in fact in the process of microfilming the notary records there. However, they are exceedingly difficult to read; we have found no one among Waldensian descendants who can read them—even if one of us had the time to do so. Brother Cena's son, Lorenzo, is a senior at BYU and told us about new scanning equipment in the Family History Center on campus. Ron Malan is beginning to scan each set of pages of the notary records, saving the images on CD. This is a very time-consuming process, and it's expensive to send the CDs to Brother Cena. Still, this remains the best alternative we have found.

It is important that we support Brother Cena as he adjusts to this difficult change in his life. He is by far our most economical, most dependable, and most accurate option. We invite your regular financial support of our research project—for the finish line is in sight! Thank you very much.

### **HELP NEEDED**

Securely shipping 1 or 2 CDs to Brother Cena costs \$48 each time—terribly expensive, as each roll of microfilm takes 2 CDs and we have 60 rolls to go!

Brother Cena has a daughter at BYU who will return home in April and is willing to take back all CDs we can prepare.

Therefore, we need volunteers who can spend a block of 3 or 4 hours at least once a week to help do this. You need access to a FHC that has the Family History software for scanning microfilms and saving the images to CD; the BYU-Provo FHC has 3 of them. Presumably, other large FHCs also have them. You also need to assure that none of the words on a page are cut off—by glancing at the computer screen.
