# **Continuing Our Research: Saving Microfilms to CD**

The unexpected passing of Sister Cena last August,2004 resulted in Brother Cena's having to move, with their two youngest sons, to the Canary Islands. That permitted him to care for the boys as well as her parents, who have not been in good health. But that also meant he was very far from the State Archives in Torino.

With the aide of his son Lorenzo, a BYU student, we discovered that some of the larger family history centers, as well as the Family History Library in Salt Lake City, had computer-linked scanners able to save microfilm images to CD. Experimenting with one volume showed that Brother Cena could readily read the results, and with only three communities in the Valleys left to abstract, it seemed crucial for us to proceed. Therefore volunteers were sought to help with this effort, using the family history centers at BYU, BYU-Idaho, and the Family History Library. One sister began at the Ogden family history center, but the program didn't function properly and none of the staff could resolve the difficulty.

We ended up with 110 CDs combined for Villar Pellice, Perosa Argentina, and Bobbio. We were able to finish those in time for Serena Cena, Lorenzo's sister, to take them home with her at the end of the BYU spring term. That not only saved us Express shipping charges, but also assured their safe arrival.

We also scanned and saved to CD some early volumes of a few towns on the plains that are mentioned as the hometowns of some ancestors identified in the records so far. We have completed an additional six CDs, with perhaps twice that number yet to go. These will have to be shipped to Brother Cena.

We wish to recognize, and publicly thank, those who assisted in this effort: Boyd Cardon, wife, Terri and daughter, Melodi C. Johnson, Grover Cardon (now on a mission with his wife), Lavor Cardon, Neil Cardon, Toni & Morris Hill, Carol Kimball, David L. Malan, Ron Malan, Anita McPherson, LaDawn McPherson, Kathy Parson, Julie Peterson, and Arva Witbeck. We especially thank Arva Witbeck, a Gardiol descendant, who scanned films at the Family History Library, where patrons are permitted to use the scanner for only one hour at a time. Persisting despite having to leave one scanner and take the microfilm to another floor in search of an available scanner for the next hour, Arva succeeding in finishing 19 CDs by herself, more than any other single participant.
