Giovanni Cena's research in the notary records continues to provide results. I have discovered the last name of Allasina, the wife Jean Jahier, b abt 1572 Pramollo, Torino, Piemonte (Regione), Italy. Her last name is **BOUCHARD**. She is the daughter of Giacobbo Bouchard.

AHNENTAFEL SYSTEM for Allasina: The number of a person's father is the double of their own number, and the number of a person's mother is the double of their own, plus one.

Waldensian Families Research Website

The PFO's Waldensian Families Research website (Waldensian.info) is fast approaching its 2 year anniversary. The purpose of the website is to make the PFO's research more widely available to Waldensian family historians throughout the world.

So far this year, the website has had more than 2,000 visits from people in 65 different countries. The most visits were from the United States (46%). There were visitors from 65 foreign countries with the most frequent being Italy (10%), France (9%), Germany (4%), Argentina (4%), South Africa (4%), Canada, UK, and Uruguay with 3% each. People from 46 different states have visited the website. The most visits came from Utah (16%), California (10%), North Carolina (7%), Arizona (6%), and Texas (6%). All of these locations have Waldensian populations so we know the website is reaching its target audience.

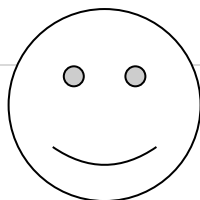
The most important resource provided is the collection of 17th century notary record abstracts. The church records were destroyed when the Waldensians were driven from the Piedmont Valleys in 1686. Many of the Notary Records however have been preserved and serve as the primary resource for researching Waldensian genealogy prior to that date. These records currently reside in the State Archives in Turin, Italy. **The major research project of the PFO is to abstract those records which contain a wealth of genealogical information. We are fortunate to have the assistance of Giovanni Cena who has access to these records. These abstracts have enabled nearly 50,000 temple ordinances since 1987.** Approximately two thirds of the surviving volumes have been abstracted so far. We are adding one or two volumes to the collection each month.

We have recently added a number of tax and census lists discovered in the Archives by Brother Cena. Also on the website is the complete book “Gli Esuli Valdesi in Svizzera” providing information about 4,000 of our ancestors who were driven from their homes in 1686 by the Duke of Savoy. You can see what property our ancestors owned by looking at the Inheritance Claims records. The website includes pedigree chart information from several of the PFO family researchers including the latest information for the Cardon, Malan, Gaudin, Rivoire, and Gardiol families. Also on the website are copies of 62 pedigree charts from the well-known Waldensian scholar and historian, Jean Jalla, which have been generously provided to us by the Waldensian Historical Archives in Torre Pellice, Italy.

In addition to genealogical data, the website contains updated information from Ron Malan’s BYU Home Study Class on how to do Waldensian genealogy research. For those who just want to know more about Waldensians, a number of articles cover the history and culture of the people. You can also learn about the newly created Waldensian DNA Project.

One of the most frequently used features of the website is the ability to make your PFO donations electronically using the highly secure PayPal application. You can still make your donations via check and the US Mail. 100% of your donations are used for genealogical research. All administrative expenses (including the website) are provided to the PFO by member volunteers.
