# CLARIFYING THE STALE-CARDON SIBILLE AND BENECH LINES

Background: The descendants of Philippe Cardon and Marthe Marie Tourn have an interesting double connection. In 1863 Philippe Cardon married Jeanne Marie Gaudin Moise, widow of Jean Pierre Stallé, who died in 1856 on the Platte River on the first handcart company. In 1857 Louis Phillip Cardon, Philippe's oldest son, married Susette Stallé, the oldest daughter of Jean Pierre Stale (Stallé) and Jeanne Marie Gaudin Moise. Through my research I have discovered that Jean Pierre Stale (Stallé) was the third great grandson of Marguerite Sibille b abt 1633 ANG and Gioanni Benech b. abt 1630 ANG md abt 1654.

In the PFO Report No. 42 August 2005 "Ancestors of Jeanne BONNET" by Ronald F. Malan and Boyd L. Cardon listed Jeanne BENECH # 5 on page 1 b. abt 1664 in ANG wife of Sidrac Bonnet b in 1663 in ANG. Her father was given as #10 Jean (Gioanni) BENECH md #11 Mrs Jean (Gioanni) Benech. There is an attached note: This line has not yet been researched. In searching the notary records I discovered that the wife of Gioanni BENECH was Marguerite SIBILLE. Marguerite SIBILLE'S parents were: Filippo SIBILLE and Miss Filippo SIBILLE and her siblings were found. Moreover the notary records also give the father of #10 Jean (Gioanni) BENECH as Pietro BENECH (Not Daniel BENECH as shown on Family Tree). In PFO Report No. 41 April, 2005 "Ancestors of (Capt.) Etienne BENECH by Ronald F. Malan and Boyd L. Cardon page 1 under the title Third Generation lists #4 Pietro BENECH b. abt 1609 in ANG md Mrs Pietro BENECH b. abt 1613 md abt 1633. After careful analysis, mediation and prayer, I have concluded that #4 Pietro is also the father of the above #10 Jean (Gioanni) BENECH listed in PFO Report 42. Thus Capt. Etienne BENECH and Jean (Gioanni) BENECH were brothers. The descendants of Jean Pierre Stallé have direct lineage from the two brothers. Capt. Etienne Benech was the 2<sup>nd</sup> great grandfather of Jean Pierre Stale.

SIBILLE: spelled in the notary records as Sibillia, Subiglia, Subilia, Sibile, Sebilia

Marguerite (Margarita) SIBILLE b abt 1633 ANG Notary record says she is the first wife of Gioanni Benech (Luserna 221 pg 1333 9Jan 1710 Will). As of yet I have not been able to identify the second wife.

## **Descendants of Jeanne Marie Gaudin Moise**

Jeanne Marie Gaudin Moise was the 3rd wife of Jean Pierre Stallé. She was the mother of Susette Stallé, Bartholomi Stallé, Marie Stallé and Margaret Stallé). She was the third great granddaughter of MARTHE GAY. MARTHE GAY had 6 children who had not received their temple ordinances. GAY in the notary records is spelled as: Giay, Gaj, Gaij.

MARTHE GAY b. abt 1661 RP md Daniel Pascal-Pasquet b. abt 1657 PR md. abt 1680 had 7 children: Maria b. abt 1681 PR, Filippo b abt 1683 PR, Anna b. abt 1685 PR; Daniele b. abt 1687 PR; Paulo b abt 1689 PR; Giacomo b abt. 1691 PR; and Gioanni b. abt 1693 a direct ancestor of Jeanne Marie Gaudin Moise whose work has been done. ### **LEST WE FORGET!**

## The Miracle of the Survival of our Ancestors

- 1. In 1630 the Bubonic plague, Black Death, struck the Waldensian valleys and killed a third of the population.
- 2. In 1655 troops were stationed with the Waldensian families. On April 24 the heinous slaughter, Piedmont Easter massacre of the Waldensian occurred.
- 3. In 1685 the Edict of Nantes was revoked which awarded Huguenots political and religious freedom.

  Thousands of French Protestants fled into the Waldensian Valleys. Louis XIV mandated Victor Amadeus, then

  Duke of Savoy, to invade the Waldensian Valley and to root out the Protestants. On the 31st of January, 1686, the following edict was sent:
- The Vaudois (Waldenses) shall henceforth and forever cease and discontinue all the exercises of their religion.
- They are forbidden to have religious meetings, under pain of death, and penalty of confiscation of all their goods.
- All their ancient privileges are abolished.
- All the churches, prayer-houses, and other edifices consecrated to their worship shall be razed to the ground.
- All the pastors and schoolmasters of the Valleys are required either to embrace Romanism or to quit the country within fifteen days, under pain of death and confiscation of goods.
- All the children born, or to be born, of Protestant parents shall be compulsorily trained up as Roman Catholics. Every such child yet unborn shall, within a week after its birth, be brought to the cure of its parish, and admitted to the Roman Catholic Church, under pain, on the part of the mother, of being publicly whipped with rods, and on the part of the father of laboring five years in the galleys.
- The Vaudois pastors shall abjure the doctrine they have hitherto publicly preached; shall receive a salary, greater by one-third than that which they previously enjoyed; and one-half thereof shall go in reversion to their widows.
- All Protestant foreigners settled in Piedmont are ordered either to become Roman Catholics, or to quit the country within fifteen days.
- By a special act of his great and paternal clemency, the sovereign will permit persons to sell, in this interval, the property they may have acquired in Piedmont, provided the sale be made to Roman Catholic purchasers.

### PFO REPORT NUMBER 66 AUGUST, 2015

In 1686 the Waldensian defenses eventually broke down before the forces of Savoy and France, and many of the Protestants were slaughtered. More than 12, 000 Protestant survivors were imprisoned in various fortresses in Savoy. Victor Amadeus softened his heart and resolved to defy Louis XIV and to free his duchy of French domination. He freed the Waldensian prisoners and financed their journey to Switzerland.

### 4. The exile from 1686-1689

On Christmas Day, 1686 after about a three weeks journey the first company of these miserable exiles arrived at Geneva, Switzerland. About 3,000 Waldensian exiles entered the gates of Geneva, a meager remnant of a population of from 14,000 to 16,000.

**5. In 1689, The Glorious Return**, Henri Arnaud led 900 men back to the Piedmont to reclaim their properties against overwhelming odds.

These amazing miracles from heaven allowed our ancestors to survive and to receive the restored gospel in 1850 to 1856 and then to immigrate to Utah. We have a very special heritage!
